### Terms and Conditions

1. All food vendors are required to remain open for sales during all event hours, no exceptions will be made. First time vendors please provide a picture of your truck/booth and power needs.
2. Only pre-approved items may be sold. No last minute additions will be permitted.
3. Vendors will be responsible for set-up, staffing, clean up of booth. Set up hours will be available as early as the Saturday before the event. Everyone must be setup at least ONE DAY before the event starts
4. Vendors are responsible for securing merchandise overnight. Sacred Heart Church is not responsible for losses due to theft of personal property left on site.
5. All vendors must comply with Pinellas County Health Department regulations and may responsible for any fees associated with permitting.
6. All food booths must have hand-washing station including soap or sanitizer, paper towels, proper food surface sanitizing and food handling abilities and equipment.
7. Proper fire extinguisher must be present at each booth and comply with Fire Codes.
8. Proper proof of insurance and liability are required.
9. Alcohol and /or drug use is prohibited by all staff members inside food booths. We are a church-related and family-oriented event. Vulgar language and disorderly conduct will not be tolerated. Please be professional.
10. No pets of any kind will be permitted in food booths or food preparation areas.
11. 120 volt electricity will be available to all vendors. **No 220 volt lines.**  
Please be prepared to supply any necessary extension cords. You may need a generator during event.
12. Propane tanks must be properly located and secured.
13. **All sales will be in ticket form. Each ticket will have a value of \$1.00. Tickets will be collected, counted and accounting will be available after the close of the event each night.**

By signing, I have read and understand all terms and conditions of participation in event. I understand the application of \$25 is non-refundable upon acceptance of this application. I will enclose copies of requested insurance and permits verification. I also agree that Sacred Heart Church is not responsible for any damages and/or loss of property during the event.

**I agree to donate 30% of sales to Sacred Heart. (Most vendors simply adjust pricing to cover donation, remember donations to a church are tax deductible)**
